(Reuters) - Republicans and Democrats in Congress are unlikely to reach a deal on a \$1.1 trillion tax cut compromise by year-end, the chairman of the Senate Finance Committee said on Friday. U.S. Senate Finance

small,” said Finance
Committee Chairman Max
Baucus, who was speaking at
a panel discussion at a health
policy conference in
Washington. Baucus said the
level of opposition to any
deal is too high and that “my

realistic assessment is it's going to be pretty tough to get the votes." Republicans and Democrats in the House of Representatives have been negotiating over the weekend on a compromise package that would cut tax rates for

individuals and families but also impose higher rates on companies that would be set in January. The White House is pressing for a package that would be signed into law by year-end. The most recent draft, agreed to by President

Barack Obama and the top congressional leaders, would extend all existing tax rates for two years, and cut rates by up to \$1.2 trillion over 10 years. “It’s not clear whether we’ll get there,” said Senator Sherrod Brown, a Democrat

from Ohio. “So we’ll have to see.” The U.S. economy was growing strongly at the end of last year, the fastest pace in more than a decade, but its sagging output has been overshadowed by worries about the budget deficit.

Brown and other panelists told the American Enterprise Institute think tank that another of the top priorities for the 111th Congress, which convenes next week, will be to deal with the public debt. Brown told the panel
